The Learning Behavior Specialist 1 (LBS1) endorsement is sought after by PK-12 teachers for the purpose of gaining an additional endorsement to be qualified to teach in a special education setting. The course titles and descriptions have been approved by the Illinois State Board of Education. The student populations with which they will be endorsed to work are diagnosed with specific learning disabilities, social emotional disorders, mental retardation, physically handicapped, autism, and traumatic brain injury. Each course may be taken for elective credit in the Master of Arts in Education degree program.
